

Niax silicone L-6887 is an organosilicone copolymer designed for resin side addition in the manufacture of rigid polyurethane foams.

Key Features and Typical Benefits

- Niax silicone L-6887 is a very efficient surfactant which may be a candidate for consideration in insulation foams, such as in refrigerators and cold storage applications. The typical use level is 2.0 to 3.0 parts per hundred of polyol (php).
- Niax silicone L-6887 maximizes the use level of pentane in formulations and allows switching from c-pentane to less soluble grades like iso- or n-pentane without causing additional haziness or phase separation.
- Niax silicone L-6887 provides extremely fine cells and therefore, low thermal conductivity with cyclopentane as well as mixtures of cyclopentane and other hydrocarbons or hydrofluorocarbon's.
- Niax silicone L-6887 improves blowing efficiency, delivers good foam flow, even density distribution and reduced void formation.
- The combined effect on fine cells and flow delivers foam with consistently low thermal conductivities throughout the foam.
