# Description

Niax Catalyst C-31 is a delayed action catalyst for the manufacture of rigid polyurethane and polyisocyanurate foams produced by continuous lamination or mould injection processes. This catalyst can facilitate accelerated foam hardening and improved green strength and foam adhesion properties and is an excellent candidate for the production of PUR or PIR foam high thickness panels.

# **Key Features and Typical Benefits**

• High selectivity toward PIR reactions, to boost the formation of a fully cross-linked polymer network after gelation occurs

• Improved surface cure, stiffness and reduced swelling of PIR insulation boards and metal faced panels.

• Improved cure of PUR foam where slow reactivity or low mould temperature tends to affect the polymer cure.

## General Considerations For Use

Typical product usage level is between 1 and 5 parts per one hundred parts polyol.

Niax Catalyst C-31 can be used in addition to an existing catalyst package while maintaining the required reaction profile.

If used in combination with a blowing catalyst, it can enable improved flow without affecting cure time.

Use of Niax Catalyst C-31 in combination with Niax Catalyst C-5 and Niax Catalyst Potassium Octoate LV and a suitable Niax Silicone is recommended.
