Product Description

Niax Catalyst A-133 contains 23 percent bis(2-dimethylaminoethyl)ether, one of the most active urethane foam amine catalysts known. It helps increase process control in the manufacture of flexible urethane slabstock and molded foam. As a matter of convenience, the pure amine has been diluted 77 percent by weight with dipropylene glycol to facilitate metering and to permit the use of conventional quantities of amine catalyst in foam formulations. The viscosity and potency of the product permit accurate control of the metering of amine catalyst on slabstock from production equipment.
