

## Niax\* Ester Additive DCF

### Product Description

Niax Ester Additive DCF is a product specially designed for improving die-cuttability of flexible polyester and ether foam. It acts as lubricant to allow sharp cuts without any problem of edge sealability. It gives smooth clean cuts with excellent foam recovery. It also acts as a mild de-foamer that opens up foams and it improves processing latitude. Niax DCF does not create fogging and it is especially recommended for automotive application. Niax DCF may help foam recovery after compression.

### Industrial Application

- Typical use levels may vary from 0.3 to 0.6 pphp depending upon formulation
- At high use levels Niax DCF could destroy the cellular cell structure or cause foam settling
- Not compatible with water and a dedicated metering line is advisable
- The compatibility of Niax DCF with other ester additives needs to be checked prior to industrial production
