Niax Silicone L-417 is a low emission stabilizer and cell regulator for the use in viscoelastic foam formulations based on MDI isocyanate. L-417 is hydrolytically stable and presents low emission characteristics and it is therefore suitable for the production of quality foam for bedding, pillows and furniture. The proper selection of MDI and polyol is critical for optimum processing and improved mechanical properties. L-417 may find application in Slabstock continuous processes and in moulded type processes.
