### Product Description

Niax silicone L-5641 is a reduced VOC, non-hydrolyzable surfactant used in the manufacture of low density mechanically frothed foams. Niax silicone L-5641 is an excellent candidate to consider for use in applications seeking to minimize air/water permeability and vibration/noise, as well as those requiring density reduction beyond that which can be provided by conventional mechanical froth surfactants such as Niax silicone L-5617.

- Improved performance of mechanically frothed foam including:
  - Reduced froth density ( < 18 pcf or 288 kg/m<sup>3</sup>) without the use of blowing agents
  - Reduced shear-induced cell collapse under doctor blade or air knife
  - Inhibited bubble coalescence in oven cure conditions
  - Fine, microporous cell structure
  - Elimination of surface bubbles
- Improved density reduction compared to Niax silicones L-5614, L-5617, and L-5639
- Greater closed-cell content compared to Niax silicones L-5614 and L-5617
- Lower VOC content compared to L-5640
