### Product Description

Niax silicone L-6188 is a non-hydrolyzable silicone copolymer used in the manufacture of polyurethane foams and is an excellent candidate for use in open cell formulations totally blown with water, having either a high or low NCO index, based on polyether or polyester polyols.

- Excellent cell opening effect and cell stabilization, which can be increased at greater silicone levels to allow delay in cell opening time
- Broad compatibility in polyol blends
- High open cell content in water-blown rigid foams

In formulations with high open cell content, catalysts such as Niax catalyst DMEE or Niax catalyst Potassium Octoate LV are recommended to minimize amine smell in the final foam.
