Niax silicone L-6645 is a silicone copolymer used in the manufacturing of rigid polyurethane foams with a range of continuous and discontinuous lamination processes. It is a versatile surfactant grade that is broadly compatible with typical rigid foam polyol blends, and can allow good foam flow.
