### **Product Description**

Niax catalyst EF-150 is a delayed, emission free blowing tertiary amine catalyst used in the manufacture of polyurethane high resilience (HR) molded foam, offering extended cream-time for improved liquid flow in the mold, as well as increased open foam with lower Force to Crush (FTC). It can also provide increased final foam hardness and good foam physical properties, comparable to those of Niax Catalyst A-400.
